Amateur Handlers Only. YOU MUST BE A MEMBER OF THE SANTA YNEZ VALLEY ARABIAN HORSE ASSOCIATION CLUB TO PARTICIPATE. HORSES MAY NOT HAVE SHOWN BEFORE - EXCEPT BY AN AMATEUR. Checks should be made out to SYVAHA as the Santa Ynez Futurity Gelding Classes are part of The Arabian Foal Festival which will be held at the Seventy Second Annual Purebred & Half Arabian Performance Fall Show in Santa Barbara at Earl Warren Showgrounds.

The Arabian Foal Festival Entry Agreement at the 72 Annual Purebred & Half Arabian Fall Horse Show

By signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Handler and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The Arabian Foal Festival and the Santa Ynez Valley Arabian Horse Association. I agree to be bound by the Bylaws and Rules of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the Competition, the officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, and SYVAHA and/or the Competition may use or assign photographs, videos, cable-casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the Competition for the promotion, coverage or benefit of the Competition, sport or the SYVAHA Club. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of The Arabian Foal Festival rules are governed by the laws of the State of California, and any action instituted against The Arabian Foal Festival and or the Santa Ynez Valley Arabian Horse Association must be filed in the state of California.

Release, Assumption of Risk, Waiver and Indemnification: The document waives important legal rights. Read it carefully before signing.

AGREE in consideration for my participation in the Competition The Arabian Foal Festival at the 72nd Annual Purebred & Half Arabian Performance Show to the following: I AGREE that "The Arabian Foal Festival and Santa Ynez Valley Arabian Horse Association or Club" AND the Arabian Horse Association of Souther California as used herein includes the Licensee and Competition Management, as well as all of their officials, officers, directors, employees, agents personnel and volunteers.

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a handler, owner, agent, coach, trainer, or as parent of guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss and serious bodily injury including broken bones, head injuries, trauma, pain, suffering or death, ("Harm"). I AGREE to hold harmless and release The Arabian Foal Festival from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results, resulted, directly or indirectly, from the negligence of the The Arabian Foal Festival, the Santa Ynez Valley Arabian Horse Association and or the Arabian Horse Association of Southern California.

I AGREE to indemnify (that is, to pay any loss, damages, or costs incurred by The Arabian Foal Festival and the SYVAHA & AHASC and to hold them harmless with respect of claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse while at the Competition. I have read The Arabian Foal Festival Rules and understand there are no penalties for wearing any kind of protective clothing. If I am a parent of guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of the Release on the child's behalf. I represent that I have the requisite training, coaching and abilities to safely compete in this competition.

I AGREE that if I am injured at this competition, the medical personnel treating me may provide information on my injury and treatment to The Arabian Foal Festival and or the Santa Ynez Valley Arabian Horse Association and or the Arabian Horse Association of Southern California.

BY SIGNING BELOW, I AGREE to be bound by all applicable Rules and all terms and provisions of the entry blank and all terms and provisions of this Prize List. If I am signing and submitting this Agreement electronically, I acknowledge that my electronic signature shall have the same validity, force and effect as if I affixed my signature by my own hand.
